The board received a request from Anna Hoppough from the Covered Bridge Cemetery Association to hold a meeting at the Town Hall on April 1st. Deputy Supervisor Gnau will unlock and lock building.

# **Park**

The Legion had the annual Vincent House softball tournament. The clay on the field was not hard enough and we received quite a bit of snow and water. The organization playing on the field with water and ground not frozen made the clay a sloppy mess that will need to be fixed before any teams can play on the field. They also left some debris behind in the dugouts. Pat Hillyard spoke and stated that the Legion is having a meeting and will be discussing the matter. There was quite a bit of volunteer labor and Town money into creating the field and upkeep to date.

# **Highway**

Discussion took place regarding issues with the small International plow truck. Repairs needed will cost \$12,000.00 International does not want to honor their Warranty. The Town will be meeting with representatives from International to discuss the Warranty. The Dodge pickup truck still has continuing issues and may have to look into getting a new pickup this year.

### Mowing

JMZ notified the Town that they will no longer be in the lawn care business. This discussion tabled to April meeting.
