Town Clerk - Town Clerk, Joyce Nisbet shared a letter received from Five Star Bank beginning January 1, 2025, a \$6.00 fee will be enforced when a taxpay purchases a Cashier Check to make their tax payment. Taxpayers who bank with Five Star Bank may be eligible for complimentary Cashier Checks. Taxpayers may continue to pay with a personal check or a cashier check/money order from their financial institution if they do not want to purchase one from Five Star Bank.

Highway Superintendent, Matt Nisbet, spoke with the Board Members that Livingston County Sewer Water Authority asked if the Town would be willing to let the County continue to store water pumps at the Quanza at the Highway Department after the Sewer project was completed; It was said this would have to be decided by the board members; Western Star will not be taking any orders for 10-Wheeler Trucks in NYS at this time; The Empire Access is in the works, they are in phase one putting in the feed line, then will start phase two which will be the service lines.
